This letter is further to your request of original June 25, 2012, filed under the *Access to Information Act* to obtain:

"The amount of legal fees and other costs associated with legal proceedings per annum from February 27, 2007 to present to challenge a complaint filed with the Canadian Human Rights Commission on February 27, 2007 by the Assembly of First Nations and the First Nations Child and Family Caring Society of Canada alleging that AANDC's program for First Nations child and family services is discriminatory. Please include costs for all Federal Court and Federal Court of Appeal matters relating to the February 27, 2012 complaint."
