Dear Ms. Blackstock:

This letter is further to a complaint filed regarding your request dated June 25, 2012, pursuant to the *Access to Information Act* to obtain:

*"The amount of legal fees and other costs associated with legal proceedings per annum from February 27, 2007 to present to challenge a complaint filed with the Canadian Human Rights Commission on February 27, 2007 by the Assembly of First Nations and the First Nations Child and Family Caring Society of Canada alleging that AANDC's program for First Nations child and family services is discriminatory. Please include costs for all Federal Court and Federal Court of Appeal matters relating to the February 27, 2012 complaint".*

Previously, we disclosed to you all the total amounts of services rendered. Further to your request and our review of the exemptions applied, the client has agreed to waive privilege on information pertaining to specific legal costs, namely:

- the sum of the Cost Recovery Reports by File Number showing Vendors' overall totals is \$68,611;
- the headings of these Cost Recovery Reports by File Number showing Vendors;
- the global amount of costs for hours spent in relation to public hearings for the time frame, and cases relevant to your request would be \$65,674;
- the total amounts of hours entered by the various timekeepers are now being disclosed; and
- the total amounts of money due for these hours are also being disclosed.

With this disclosure, we trust that we have satisfied your request. Please note that the remaining information will continue to be subject to section 23 [solicitor-client privilege] of the *Access to Information Act*.

Also, during the process of this complaint, 13 new pages were identified. Therefore, a subsequent release will shortly follow.
